Legislative Bill summary;    - Medicaid Replacement –passed  
- Catastrophic Aid change still being discussed but  
appears it will pass which will raise the categorical

aid for special education funding.

Alicia gets credit for figuring out the Medicaid Fee For Service billing system. ANW is slightly above last years billing at this same time. Administrative billings for our districts were discussed.

New OT has signed her contract for the 2010/2011 school year. Emily Williams was an OT student a couple of years ago; she will be assigned to the north end since the KU program is not being renewed for next year.

SLP position open, ANW has posted the opening on KEEB and has posted with all Kansas University placement offices with speech programs.

Notice & consent for changing an IEP must occur if the change is for 25% or more for service time or there is a change in placement. Substantial changes in any way to the IEP must have consent & give notice which is a compliance issue.

Serving students past age 18, outside agencies are also feeling the financial pinch. Staff are asked to get Bob involved so agencies will make those placements for adult services. Several options are there for the 18-21 year olds.

Discussion re: Infinitec workshop was attended by Ron Harley & Jay Parker. There is a vast amount of resources within Infinitec which is available to all ANW staff.

Committee consensus: Ron will set up a webinar for the next Advisory meeting April 14<sup>th</sup> on Infinitec and make plans for other webinars throughout the school year.
